**SECTION 4 : FIRST AID MEASURES**

**4.1. Description of first aid measures****In the event of exposure by inhalation :**

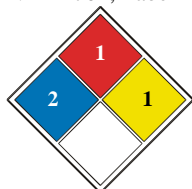
